This is a commercial product whose exact ratio of components may vary slightly. Minor quantities of other non hazardous ingredients are also possible.

The TWA exposure value is the average airborne concentration of a particular substance when calculated over a normal 8 hour working day for a 5 day working week. The STEL (Short Term Exposure Limit) is an exposure value that should not be exceeded for more than 15 minutes and should not be repeated for more than 4 times per day. There should be at least 60 minutes between successive exposures at the STEL. The term "peak" is used when the TWA limit, because of the rapid action of the substance, should never be exceeded, even briefly.

## Section 4 - First Aid Measures

### General Information:

You should call The Poisons Information Centre if you feel that you may have been poisoned, burned or irritated by this product. The number is 13 11 26 from anywhere in Australia (0800 764 766 in New Zealand) and is available at all times. Have this SDS with you when you call.

**Inhalation:** First aid is not generally required. If in doubt, contact a Poisons Information Centre or a doctor.

**Skin Contact:** Irritation is unlikely. However, if irritation does occur, flush with lukewarm, gently flowing water for 5 minutes or until chemical is removed. If in doubt obtain medical advice.

**Eye Contact:** No effects expected. If irritation does occur, flush contaminated eye(s) with lukewarm, gently flowing water for 5 minutes or until the product is removed. Obtain medical advice if irritation becomes painful or lasts more than a few minutes.

## Section 5 - Fire Fighting Measures

**Fire and Explosion Hazards:** There is no risk of an explosion from this product under normal circumstances if it is involved in a fire. Violent steam generation or eruption may occur upon application of direct water stream on hot liquids.

Fire decomposition products from this product are likely to be toxic and corrosive if inhaled. Take appropriate protective measures.

**Extinguishing Media:** Preferred extinguishing media are carbon dioxide, dry chemical, foam, water fog.

**Fire Fighting:** When fighting fires involving significant quantities of this product, wear a splash suit complete with self contained breathing apparatus.

## Section 6 - Accidental Release Measures

**Accidental release:** Minor spills do not normally need any special cleanup measures. In the event of a major spill, prevent spillage from entering drains or water courses. As a minimum, wear overalls, goggles and gloves. Suitable materials for protective clothing include rubber, PVC. Stop leak if safe to do so, and contain spill. Absorb onto sand, vermiculite or other suitable absorbent material. If spill is too large or if absorbent material is not available, try to create a dike to stop material spreading or going into drains or waterways. Sweep up and shovel or collect recoverable product into labelled containers for recycling or salvage, and dispose of promptly. After spills, wash area preventing runoff from entering drains. If a significant quantity of material enters drains, advise emergency services. Full details regarding disposal of used containers, spillage and unused material may be found on the label. If there is any conflict between this SDS and the label, instructions on the label prevail. Ensure legality of disposal by consulting regulations prior to disposal. Thoroughly launder protective clothing before storage or re-use. Advise laundry of nature of contamination when sending contaminated clothing to laundry.

## Section 7 - Handling and Storage

**Handling:** Keep exposure to this product to a minimum, and minimise the quantities kept in work areas. Check Section 8 of this SDS for details of personal protective measures, and make sure that those measures are followed. The measures detailed below under "Storage" should be followed during handling in order to minimise risks to persons using the product in the workplace. Also, avoid contact or contamination of product with incompatible materials listed in Section 10.

**Storage:** Make sure that containers of this product are kept tightly closed. Keep containers of this product in a well ventilated area. Make sure that the product does not come into contact with substances listed under "Materials to avoid" in Section 10. Some liquid preparations settle or separate on standing and may require stirring before use. Check packaging - there may be further storage instructions on the label.

The ADI for Diflufenican is set at 0.2mg/kg/day. The corresponding NOEL is set at 16.3mg/kg/day. ADI means Acceptable Daily Intake and NOEL means No-observable-effect-level. Values taken from Australian ADI List, June 2014.

**Ventilation:** No special ventilation requirements are normally necessary for this product. However make sure that the work environment remains clean and that vapours and mists are minimised.

**Eye Protection:** Eye protection is not normally necessary when this product is being used. However, if in doubt, wear suitable protective glasses or goggles.

**Skin Protection:** The information at hand indicates that this product is not harmful and that normally no special skin protection is necessary. **Reactivity:** This product is unlikely to react or decompose under normal storage conditions. However, if you have any doubts, contact the supplier for advice on shelf life properties.

**Incompatibilities:** strong acids, strong bases, strong oxidising agents.

**Fire Decomposition:** Carbon dioxide, and if combustion is incomplete, carbon monoxide and smoke. Nitrogen and its compounds, and under some circumstances, oxides of nitrogen. Occasionally hydrogen cyanide gas. Hydrogen fluoride gas and other compounds of fluorine. Water. Carbon monoxide poisoning produces headache, weakness, nausea, dizziness, confusion, dimness of vision, disturbance of judgment, and unconsciousness followed by coma and death. Hydrogen cyanide poisoning signs and symptoms are weakness, dizziness, headache, nausea, vomiting, coma, convulsions, and death. Death results from respiratory arrest. ## Potential Health Effects

### Inhalation

**Short term exposure:** Available data indicates that this product is not harmful. In addition product is unlikely to cause any discomfort or irritation.

**Long Term exposure:** No data for health effects associated with long term inhalation.

## Section 12 - Ecological Information

This product is harmful to aquatic organisms.

**Birds:** Oral LD<sub>50</sub> for quail >2150mg/kg, for mallard ducks >4000mg/kg

**Fish:** LC<sub>50</sub> (96hr) for rainbow trout 56-100, carp 105mg/L

**Bees:** nontoxic to honeybees

**Worms:** nontoxic to earthworms

**Daphnia:** LC<sub>50</sub> (48hr) no effect at 10mg/L

**Algae:** EC<sub>50</sub> for *Scenedesmus subspicatus*: no growth inhibition at 10mg/L

### Environmental fate:

**Plants:** In cereals, rapidly metabolised via nicotinamide and nicotinic acid to carbon dioxide. Following pre-emergence application in autumn, no residues were detectable in grain and straw after about 200-250 days.

**Soil/Environment:** In soil, degradation proceeds to bound residues plus carbon dioxide. Half lives vary from 15 to 30 weeks depending on soil type and water content.
