



OPEN HERE

Triple rinse the containers. Do not re-use the empty containers for any other purpose.

Tahadhari ya utumiaji: ELEGANT 2FD 306 SE ni dawa ya kuthibiti kwekwe kwenye ngano. Haistahili kutumiwa kwa njia nyingine. Geuza dawa hii na dawa ya aina nyingine katika msimu ili kuhakikisha kwekwe haiwezi kujikinga na madhara ya dawa hii. Usinyunyizie zaidi ya mara moja kwa msimu.

Mode of action: ELEGANT 2FD 306 SE contains 2,4-D that produces uncontrollable, unsustainable weed growth, as well as florasulam that inhibits synthesis of amino acids.

Directions for use: Mix with water and apply onto broad leaved weeds during early vegetative stages of weed growth (with 4 to 6 leaves).

Pre-harvest interval: 25 days

Use limitations: Alternate application of ELEGANT 2FD 306 SE with other herbicides with different modes of action so as to avoid development of resistance. Do not exceed 1 application per season. 2,4-D evaporates in temperatures above 30°C. Do not spray in the hot sun. Do not spray in the wind. Drift to sensitive crops will cause damage to them. Avoid drift to neighboring sensitive crops.

Handling precautions: Keep out of reach of children. Do not ingest. It may cause irritation of nose, throat, eyes and skin. Do not breathe spray mist. Use overall, gloves and mask when handling. Do not eat, drink or smoke while handling the product.

Safety when mixing: Wear protective clothing when mixing. Avoid contamination from spray liquid by spillage and drift.
