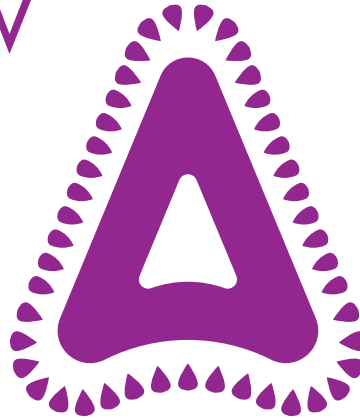

JINSI INAVYOFANYA KAZI: DARVIN 50EW ni dawa ya kuangamiza wadudu kwa kudhuru kupumua na kutembea kwa wadudu hao.
JINSI YA KUTUMIA: Changanya na maji kulingana na kiwango kilichoandikwa kisha unyunyize kwenye mikuta, sakafu na samani ambazo zimeashambuliwa na mende na sisimizi.

THIBITISHO: Dhamana ya muuzaji imeshauriwa na masharti yaliyowekwa kwenye kijikaratasi na label. Muuzaji hahusiki kamwe na madhara yoyote yanayotokana na utumiaji wa dawa hii kwa njia zinazohatarisha maisha.

DESCRIPTION: DARVIN 50 EW is a public health insecticide for the control of Cockroaches and Ants.

Mode of action: DARVIN 50EW contains diazinon, an organophosphorous insecticide which acts by inhibiting acetylcholinesterase.

DIRECTIONS FOR USE: Mix with water at the recommended rates and apply onto infested walls, floors and furniture.

Handling precautions: Keep out of reach of children. Do not ingest. It may cause irritation of nose, throat, eyes and skin. Do not breathe spray mist. Use overall, gloves and mask when handling. Do not eat, drink or smoke while handling the product.

Safety when mixing: Wear protective clothing when mixing. Avoid contamination from spray liquid by spillage and drift.

Safety when spraying: Wear protective clothing when spraying. Avoid contamination from spray liquid by spillage and drift.

Safety after spraying: Wash hands and body thoroughly after spraying.

STORAGE: Store DARVIN 50EW under lock and key and out of reach in a cool dry place away from food, feed, children and animals and from direct sunlight. Store below 30°C.

DISPOSAL OF WASTE AND EMPTY CONTAINERS: Triple rinse the containers and dispose in accordance with national regulations. Do not re-use the empty containers for any other purpose. Do not allow material to enter sewers or bodies of water.

LEAKAGE AND SPILLAGE: If leakage of the liquid or spray mix occurs, soak up material with sand, soil or sawdust. Collect this contaminated material and dispose in accordance with national regulations.

ENVIRONMENTAL HAZARDS: The product is toxic to bees, birds and fish. Do not allow material to enter sewers or bodies of water.

FIRST AID MEASURES: If poisoning is suspected, stop work immediately. Remove victim from the area of contamination and if clothing is contaminated, remove it. In case of contact with eyes, wash off with plenty of water for at least 15 minutes, including the area under the eyelids. If irritation persists, consult an eye specialist. In case of contact with skin, remove affected clothing and wash all exposed skin area with soap and water, followed by warm water rinse. Consult a doctor if irritation persists. Wash contaminated clothing before re-use. If inhaled, remove victim to fresh air. Keep victim warm and at rest. If breathing is irregular or stopped, give oxygen. Seek medical attention. If swallowed,



do not induce vomiting. Seek medical attention immediately and show this label.

TOXICOLOGICAL INFORMATION / Note to DOCTOR:

Symptoms of poisoning: Sweating, weakness, salivation, nausea, diarrhoea, bradycardia, tachycardia, bronchorrhoea, small pupils, central nervous system depression, fasciculation and convulsions.

ANTIDOTE: Atropine sulphate

NOTE TO THE PHYSICIAN: Persons with manifest peripheral symptoms should be treated with 2-4 mg of atropine sulfate and 1000 mg pralidoxime chloride or 250 mg of toxogonin (adult dose) by slow intravenous injection. More atropine may be given as needed. Persons with severe intoxication with respiratory difficulties, convulsions and unconsciousness should immediately be given atropine and a reactivator. In such severe cases 4-6 mg of atropine sulfate should be given initially followed by repeated doses of 2 mg at 5-10 min intervals. lazepam may be given to control convulsions. The patient's condition including respiration, blood pressure, pulse frequency, salivation and convulsions should be carefully observed as a guide to further administration of atropine.
