Jinsi inavyofanya kazi: ZOOMER COMBI 390 SC imetengenezwa kwa glyphosate na oxyfluorfen ambazo zinazuia kwekwe kukua vizuri.

Jinsi ya kutumia: Changanya na maji kulingana na kiwango kilichoandikwa kisha unyunyize kabla ya kupanda 'baby corn' ili kuangamiza kwekwe.

Tahadhari ya utumiaji: ZOOMER COMBI 390 SC ni dawa ya kuangamiza kwekwe kabla ya kupanda 'baby corn' Haistahili kutumiwa kwa njia nyingine. Usitumie baada ya kupanda mahindi.

Hadhari inapotumiwa: Weka mbali na watoto, wanyama na chakula cha watu na wanyama. Yaweza kuleta muwasho kwenye mapua, koo, macho na ngozi. Tumia 'overall', mipira ya mikono na vazi la kufunika uso. Usile, kunywa wala kuvuta sigara utumiapo dawa.

Kuchanganya kwa usalama: Epuka kugusana na dawa unapoichanganya. Vaa 'overall', mipira ya mikono na vazi la kufunika uso unapoichanganya.

Kunyunyizia kwa usalama: Vaa mavazi ya kujikinga na dawa unaponyunyizia. Usijichafue na maji ya dawa. Hakikisha upepo hauisukumi dawa upande wako.

Usalama baada ya kutumia: Nawa mikono na mwili vizuri. Usitumie mkebe mtupu kwa kazi ingine yoyote. Tupa vyema mkebe mtupu.

Uhifadhi: Weka na kufungia ZOOMER COMBI 390 SC mbali na watoto na wanyama. Weka mahali pakavu ambapo kipimo cha joto hakizidi 30°C. Weka mbali na moto na ndimi zake. Ikingia machoni, osha mara moja kwa maji mengi safi kwa dakika 15. Muone daktari maumivu yakizidi. Ikiwata wakati wa kupumua, mwondoe mwadhiriwa na umweke mahali penye hewa safi. Tafuta matibabu zaidi madhara yakizidi. **Ikimezwa,** usilazimisha muathiriwa kutapika. Osha mdomo kwa kutumia maji mengi. Usimpe mtu aliyezimia kitu chochote kupitia mdomo. Peleka muathiriwa hospitalini madhara yakizidi.

DESCRIPTION

ZOOMER COMBI 390 SC is an agricultural post-emergence non-selective herbicide for the control of broad leaved weeds and grasses before planting of baby corn.

Mode of action: ZOOMER COMBI 390 SC contains glyphosate and oxyfluorfen which inhibit cell functions.

Directions for use: Mix with water at the recommended rates and apply to control broad leaved weeds and grasses before planting of baby corn.

Application rates:

Use	Time of application	Rate/ha	Rate in 20 L of water
Baby corn	When weeds are actively growing but 3 days before planting	2.5 L in 400L of water	125 mL

Use limitations: Do not apply after planting of baby corn.

Handling precautions: Keep out of reach of children. Do not ingest. It may cause irritation of nose, throat, eyes and skin. Do not breathe spray mist. Use overall, gloves and mask when handling. Do not eat, drink or smoke while handling the product.

Safety when mixing: Wear protective clothing when mixing. Avoid contamination from spray liquid by spillage and drift.

Safety when spraying: Wear protective clothing when spraying. Avoid contamination from spray liquid by spillage and drift.

Safety after spraying: Wash hands and body thoroughly after spraying. Do not reuse the empty container. Dispose the container safely and according to national regulations.

Storage: Store ZOOMER COMBI 390 SC under lock and key and out of reach in a cool dry place away from food, feed, children and animals and from direct sunlight. Store below 30°C.

Disposal of waste and empty containers: Dispose the container safely and according to national regulations. Do not allow material to enter sewers or bodies of water. Triple rinse the containers. Do not re-use the empty containers for any other purpose.

Leakage and spillage: If leakage of the liquid or spray mix occurs, soak up material with sand or soil. Collect this contaminated material and dispose according to national regulations.

Environmental hazards: The product is toxic to fish; do not allow escape to water sources.

FIRST AID MEASURES

If poisoning is suspected, stop working immediately. Check for any signs of distress. Remove victim from area of exposure.

In case of skin contact, remove contaminated clothing. Wash all exposed skin area with soap and water, followed by warm water rinse.

Consult a doctor in the event of any complaints. In case of eye contact, wash out with plenty of water with the eyelid held wide open for at least 15 minutes. If pain persists, consult an eye specialist.

In case of inhalation, remove victim to fresh air. Consult a doctor in the event of any complaints. **In case of ingestion,** do not induce vomiting. Wash out mouth with plenty of water. Never give anything by mouth to an unconscious person. Consult a doctor in the event of any complaints.

Symptoms of poisoning: Vomiting, nausea, diarrhoea and flu-like symptoms may accompany exposure. Reddening and irritation may accompany dermal or ocular exposures.
