

DESCRIPTION

ZOOMER is an agricultural post-emergence non-selective herbicide for the control of broad leaved weeds and grasses in field crops, orchards and coffee.

Mode of action: ZOOMER contains glyphosate and oxyfluorfen which inhibit cell functions.

Directions for use: Half fill the tank with water. Add the required amount of ZOOMER and water in a separate container and mix well until the mixture is thoroughly uniform. Add the mixture to the tank and add water to the required amount as the agitator is running.

Handling precautions: Keep out of reach of children. Do not ingest. It may cause irritation of nose, throat, eyes and skin. Do not breathe spray mist. Use overall, gloves and mask when handling. Do not eat, drink or smoke while handling the product.

Safety when mixing: Wear protective clothing when mixing. Avoid contamination from spray liquid by spillage and drift.

Safety when spraying: Wear protective clothing when spraying. Avoid contamination from spray liquid by spillage and drift.

Safety after spraying: Wash hands and body thoroughly after spraying. Do not reuse the empty container. Dispose the container safely and according to national regulations. Storage: Store ZOOMER under lock and key and out of reach in a cool dry place away from food, feed, children and animals and from direct sunlight. Store below 30^oC. Disposal of waste and empty containers: Dispose the container safely

and according to national regulations. Do not allow material to enter sewers or bodies of water. Triple rinse the containers. Do not re-use the empty containers for any other purpose.

Leakage and spillage: If leakage of the liquid or spray mix occurs, soak up material with sand or soil. Collect this contaminated material and dispose according to national regulations. Environmental hazards: The product is toxic to fish; do not allow escape to water sources.

FIRST AID MEASURES

If poisoning is suspected, stop working immediately. Check for any signs of distress. Remove victim from area of exposure.

In case of skin contact, remove contaminated clothing. Wash all exposed skin area with soap and water, followed by warm water rinse. Consult a doctor in the event of any complaints. In case of eye contact, wash out with plenty of water with the eyelid held wide open for at least 15 minutes. If pain persists, consult an eye specialist. In case of inhalation, remove victim to fresh air. Consult a doctor in the event of any complaints. In case of ingestion, do not induce vomiting. Wash out mouth with plenty of water. Never give anything by mouth to an unconscious person. Consult a doctor in the event of any complaints
