

### Description

PYRINEX QUICK 256ZC is a non-systemic insecticide for the control of Russian Aphids On Wheat.

### Mode Of Action

PYRINEX QUICK 256ZC is a cholinesterase inhibitor, acts as a contact and stomach action with a very good knockdown effect and a very good persistent action due to micro encapsulated *Chlorpyrifos*.

### Direction For Use

Crop	Pest	Application Rate	Pre-Harvest Interval
Wheat	Russian Aphid	1.25L/Ha 25ml/20L water	14 Days

**Re-entry period:** After 6 hours.

**Preparation for spray mixture:** Spray tank with clean water, premix the required amount of PYRINEX QUICK 256ZC with a small amount of water and add to the spray tank while agitating continuously. Agitate the sprayer during use or in case of interruption of the spray process.

**Application Timing and Technique:** Start the application during the first signs of insects manifestation. PYRINEX QUICK 256ZC can be applied by any suitable knapsack sprayer which is able to distribute the spray.

### Hazards/Precutions

**Handling:** Wear protective clothing namely overalls, footwear, gloves, and face shield when preparing and using the product. Do not eat, drink or smoke when working with the product.

**After Work:** Change protective clothing and wash hands and face thoroughly with soap and clean water. Wash the spraying equipment and contaminated clothing carefully.

**Storage:** Store in original tightly closed container in a cool dry place, safely locked, away from food and animal feed stuffs, children, animals and unauthorised persons.

**Disposal:** Dispose of by triple rinsing and crushing or perforating empty containers and throwing them away in an authorized landfill site or dispose in a safe place away from water supplies. Do not re-use empty containers for any other purpose. Pesticide spray mixture of rinsate that cannot be used must be disposed of in a safe place where it cannot contaminate surface water and ditches or by spraying in a fallow land.

**Pesticide Leakages and Spillage:** In the event of heavy spillage, collect the contaminated soil layer and dispose in a safe place away from water supplies. Soaking in sand, soil or sawdust may collect small spillage. Contaminated absorbent material must be stored in marked waste bins prior to disposal in authorized landfill site. The pesticide store must be decontaminated by washing with a lot of water.

**Wildlife And Environmental Protection:** PYRINEX QUICK 256 ZC is toxic to fish & other aquatic organisms. Its harmful to birds and animals. Do not contaminate ponds and waterways by direct application, cleaning of equipment, disposal of wastes and empty container. Keep livestock and wildlife out of treated areas. Toxic to bees- Do not spray in full bloom.

### FIRST AID INSTRUCTIONS

**Inhalation contact:** Remove from exposure area to fresh air immediately perform artificial respiration if necessary. Keep person warm and at rest. **Skin contact:** Remove contaminated clothing and shoes immediately. Wash with soap or mild detergent and large amounts of water until no evidence of chemical remains Get medical attention immediately. **Eye Contact:** Wash eyes immediately with large amounts of water or normal saline, occasionally lifting Upper and lower lids, until no evidence of a chemical remains. **Ingestion:** wash out mouth with plenty of water. Get medical attention. Never give anything by mouth to an unconscious. In all cases seek medical attention immediately.

### TOXICOLOGICAL INFORMATION

**Symptoms of Poisoning:** Headache, dizziness, blurred vision, discomfort in the chest, weakness, nervousness, sweating, salivation uncontrollable muscle twitchiness, convulsion and coma.

**Antidote:** Antidote 1: Atropine sulfate. Antidote 2: Obidoxime chloride or Pralidoxime (PAM) Suggest serum and/or RBC cholinesterase determination. If ingested perform gastric lavage and administer activated charcoal.

**Note To Physician: Treatment:** Treat symptomatically.



**Muda Salama Wa Kuingia Shambani:** Baada ya masaa 6.

**Kutayarisha dawa:** Changanya kiasi kinachohitajika cha PYRINEX QUICK 256ZC kwa kiasi kidogo cha maji, ongeza kiasi cha maji kilichosalia na uendelee kutingisha bamba na kukoroga mchanganyiko wa dawa.

**Jinsi na wakati wa kutumia:** Itumie zionekanapo dalili za mwanzo za mashambulizi ya wadudu. PYRINEX QUICK 256ZC inaweza nyunyiziwa kwa kutumia bomba la maji lililochanganywa na dawa. Kwa matokeo mema hakikisha dawa imesambazwa kwenye sehemu zote za mmea.

### Hatari na Tahadhari

**Matumizi:** Vaa ngao la kujikinga, viatu na viziwi vya mikono na osho (face shield), unapotarisha mchanganyiko wa dawa na maji na unaponyuniza dawa. Jihadhari usipumue mvuke wa dawa, mchanganyiko wa dawa usingie kwenye macho au kumwagika ngozi na nguo ulizovalia. Usinyunize dawa hii ukielekea upande upepo unatoka. Usivute sigara na usile wala kuniwa wakati unapotumia dawa hii.

**Baada ya kazi:** Vaa ngao za kazi na viziwi vya kujikinga, oga mikono na uso kwa kutumia sabuni na maji safisha bomba la kunyunyiza dawa na mavasi yaliyomwagikiwa na dawa.

**Kuhifadhi:** Hifadhi dawa hii katika chombo chake asili ambacho kimefunikwa sawa sawa na kuwekwa kwenye ghalala la madawa lililoidhinihshwa. Ni lazima watoto na watu wasioruhusiwa wakatazwe kuingia kwenye ghalala la madawa.

**Utupaji:** Safisha mkoba wa dawa iliyoisha kwa kusuuza mara tatu kisha utoboe au ubonyeze na utupilie mbali na maji. Mchanganyiko wa dawa ambao haujatunika au maji yaliyoosha vyombo ni lazima yatupiliwe mahali salama na ambapo pameidhinihshwa.
