GENERAL INFORMATION

Methomex 90SP is a broad- spectrum systemic carbamate that is effective against pests resistant to organophospate and pyrethroid pesticides. It has a fast contact, quick knockdown

pyrethroid pesticides. It has a fast contact, quick knockdown and residual activity and, low volatility. Methomex 90SP generally works by contact, ingestion and systemic action. **Direction of use - Methomex 90SP** is effective against a wide range of leaf eating and sap-sucking insect pests including bean flower thrips, green peach aphid, tobacco white fly, golden wing moth, African bollworm, etc, in fruit trees, vegetables and flowers and, capsid bug, antestia bug and

giant looper in coffee. **Preparation of spray mixture** - Fill spray tank full with water. Dump entire contents into spray tank immediately after opening outer package. Do not touch the inner bag and ensure that handling does not cause the breakage of inner bag.

Do not ingest, avoid contact with skin and clothing. Do not break inner pack, drop directly into water, after opening the

outer package. Wear protective clothings namely: Gloves, goggles, boots, hat, mask or respirator suitable for protection against methomyl vapour. Do not eat, drink or smoke when handling the product. Storage

Keep out of reach of children, under lock and key. Keep away from food, feedstuffs, fertilizers or seed. Store in cool and dry conditions in original container away from heat, sparks and open flame. packs carefully to Handle the prevent breakage of inner bags, containing **Methomex 90SP** powder. Disposal

Do not flush or contaminate public sewer systems with Methomex 90SP or its waste materials. Do not contaminate ponds, waterways or ditches with Methomex 90SP waste/ contaminated materials. Dispose of in accordance with local regulations

Spill or leak Procedures

Dike large spills using absorbent impervious materials such as sand or clay. Recover remaining spilled materials as appropriate.

Collect and contain the contaminated absorbent and dike materials for disposal. Absorb small spills on/with sand. Place contaminated materials in appropriate container for disposal. Wear protective clothing during clean-up activities namely: self-contained breathing apparatus, chemical resistant gloves, face shield, goggles, and boots. Ensure adequate decontamination of tools and equipment following the clean up and wash thoroughly with soap and water after clean up.

ENVIORMENTAL HAZARDS

Methomex 90SP is toxic to bees, birds, fish and wildlife. Do not apply when run-off is likely to occur. Do not contaminate water by cleaning of equipment or disposal of associated wastes. Apply **Methomex 90SP** in the evening or early morning when bees are not foraging.

FIRST AID PROCEDURE

Consult physician for emergency. Keep in store 0.5 mg atropine sulphate tablets. Call a physician at once in all cases of suspected poisoning. If swallowed: Induce vomiting immediately by giving 2 glasses

of water and sticking finger down the throat. Never give anything by mouth to an unconscious person.

If on skin: Remove contaminated clothing and footwear. Immediately flush the skin with plenty of water for at least 15 minutes.

If inhaled: Remove the patient to fresh air. If not breathing, give artificial respiration, preferably mouth-to-mouth. If breathing is difficult, give oxygen

If in eyes: Immediately flush eyes with plenty of clean water for at least 15 minutes. If warning symptoms appear, before

the physician arrives, immediately swallow 2 and half a t ropine t ablet s (each 0.5 mg), thereafter, take 1 atropine tablet every 10-15 minutes until the throat becomes dry and the skin becomes dry and flushed. Take additional tablets as

the skin becomes dry and flushed. Take additional tablets as necessary to maintain a moderately dry throat and flushed skin until the physician arrives. **TOXICOLOGICAL INFORMATION Methomex 90SP 90SP** (Methomyl) is a carbamate insecticide, acting as a reversible cholinesterase inhibitor. **Methomex 90SP** may be fatal if swallowed or inhaled and is slightly toxic when in contact with chin skin.

Symptoms of poisioning May include weakness, blurred vision, headache, nausea, abdominal cramps, discomfort in the chest, and constrictions of pupils, sweating, slow pulse, and muscle tremors.

Antidote - Atropine sulphate. NOTE TO THE PHYSICIAN

Administer repeated doses of Atropine 1.2-2.0 mg intravenously every 10-30 minutes until full atropinization is achieved. Administer artificial respiration or give oxygen as may be required. Do not use morphine or 2- PAM.
