

**General information:** ARDENT 50SC is a suspension concentrate contact and translaminar fungicide for the control of powdery mildew on Roses and rusts on Carnations.

**Mode of Action:** ARDENT 50SC is absorbed through the roots and translocated in the xylem to the stems and leaves, or through leaf surfaces to the leaf tips and growing edges. Acts by inhibition of mitochondrial respiration in fungi. It inhibits spore germination, mycelial growth, and spore production.

**Recommendation For Use:**

Crop	Disease	Application Rate
Roses	Powdery mildew	500ml/Ha, 50ml/100L water, 10ml/20ltr of water
Carnations	Rust	500ml/Ha, 50ml/100L water, 10ml/20ltr of water

**Preparation of Spray Mixture:** Fill the spray tank with half amount of water. Add the required amount of Ardent 50SC, then fill the water to the required level and mix or agitate thoroughly to uniformity. Ensure that the spray mixture is used the same day.

**Application timing:** Start applying Ardent 50SC when the first signs of diseases infestation appear or when weather condition favor disease development. Spray Ardent 50SC regularly at 7 to 14 days interval depending on intensity of shoot growth and susceptibility of the variety.

**Applications Technique:** Ensure good coverage of the crop canopy by using a spray volume of 1000L per Ha.

**Resistance Management:** ARDENT 50 SC should always be applied as a preventive treatment. Not less than two or more than three consecutive applications must be done in a block application in any crop per season.

**RE-ENTRY PERIOD:** 6 hours

**HAZARDS/ PRECAUTIONS:**

**Handling:** Wear protective clothing namely overalls, footwear, gloves, and face shield when preparing and using the product. Do not eat, drink or smoke when working with the product.

**Storage:** Keep out of reach of children. Store in tightly closed original container in a cool dry well ventilated place, under lock key so that unauthorized persons do not have access. Keep away from food, drinks and animal feeding stuffs.

**Disposal:** Triple rinse, puncture or crush empty containers before disposal in a safe and authorized place in accordance with National regulations on chemical disposal. Do not re-use empty containers for any other purpose. Pesticide spray mixture or rinsate that cannot be used must be disposed where it cannot contaminate surface water and ditches

**Pesticide Leakage and Spillage:** In event of heavy spillage, collect the contaminated soil layer and dispose in an authorized place away from water supplies. Soaking in sand, soil or s awdust may collect small spillage. Contaminated absorbent material must be stored in marked waste bins prior to disposal in authorized landfill site. The pesticide store must be decontaminated by washing with a lot of water.

**Wildlife and Environmental Protection:** ARDENT 50SC is toxic to fish and other aquatic organism. It is harmful to birds, animals and relatively non- toxic to bees. Keep livestock and wildlife out of treated areas.

**FIRST AID INSTRUCTIONS:**

**Skin contact:** Remove affected clothing and wash all exposed skin area with soap and water, followed by warm water rinse. Consult a doctor in the event of any complaints.

**Eye contact:** Wash off with plenty of water (15 min.) If pain persists, consult an eye specialist.

**If inhaled:** Remove victim to fresh air. Consult a doctor in the event of any complaints.

**If swallowed:** Do not induce vomiting. Wash out mouth with plenty of water. Never give anything by mouth to an unconscious person. Consult a doctor in the event of any complaints.

ARDENT 50SC is unlikely to cause harm under normal use.

**Note To Physician:** Treat symptomatically.



**Jinsi Inayofanya kazi:** ARDENT 50SC hufyonza kupitia mizizi na kuenea kwa matawi na shina. Hufanya kazi kwa kuzua ukuzi wa kungu inayosababisha magonjwa.

**Mapendekezo Ya Matumizi:**

**Kutayirisha Dawa:** Changanya kiasi kinachotajikika cha Ardent 50SC pamoa na kivilango kidogo cha maji. Ongeza kiasi cha maji kilichosilia na uendelea kutingiza bomba au kukoroga mchanganyiko wa dawa na maji. Tumia mchanganyiko wa dawa siku hiyo uliotayarishwa.

**Wakati wa Kutumia:** Anza kutumia Ardent 50SC wakati dalili za ugonjwa zinapoonekana au wakati halii ya anga inafaa kwa kueneza ugonjwa. Endelea kutumia Ardent 50SC baada ya siku 7 hadi 14 kulingana na vile mmea unavyo.

**Kuzua Upizani:** ARDENT 50SC inahimizwa kunyonyiziwa kama kinga. Nyunyiza mara 3 kwa shamba la maa kwa misumi.

**Muda Salama Wa Kuinginga Shamba Lilionyuniyiwa Dawa:** Masaa 6.

**HATARI NA TAHDHARI:**

**Matumizi:** Vaa ngao la kujikinga, viatu na vizuizi vya mikonona osho (face shield), unapotayarisha mchanganyiko wa dawa na maji na unaponyuniiza dawa. Jihadhari usipumue mvuke wa dawa, mchanganyiko wa dawa usingie kwenye machi au kumwagikia ngozi na nguo ulizovilia. Usinyuyizie dawa hii ukieleka upande uepep unatoka. Usivute sigara na usile wala kunya wakati unapotumupi dawa hii.

**Baada ya kazi:** Vua nguo za kazi na vizuizi vya kujikinga, oga mikono na uso kwa kutumia sabuni na maji. Safisha bomba la kunyuniyiza dawa na mavazi yaliyomwagiki na dawa.

**Kuhifadhi:** Hifadhi dawa hii katika chombo chake asilimba chake kimemfukwa sawa na kuweku kwenye ghala la madawa ililioidhiniwa. Ni lazima watoto na watu wasioruhusiwa wakatazwe kuingia kwenye ghala la madawa.

**Utupaji:** Safisha mkoba wa dawa ilioiyisha kwa kususa mara tatu kisha utoboe au ubonyeza na utupili mbali na maji ambapo ni salama na panapoidhiniwa kulingana na sheria za utupaji. Mchanganyiko wa dawa ambaa haujumtia au maji yaliyoosha vyombo ni lazima yatupiliwali mahali salama na ambapo pameidhiniwa. **Dawa Ikimwagika au Kuvuju:** Chukua mchanga uliomwagikiwa na dawa, utupe mahali ambapo ni salama na mbali na maji. Dawa ikivuju, iloweshe kwenye sehemu ndogo ya mchanga au 'swadust' kisha ufungie mahali ambapo ni salama kabla ya kutupilia mbali mahali ambapo pameidhiniwa. Ghala la madawa ni lazima lioshwe mra kwa mra ili kuto takataka ya dawa iliomwagika au kuvuju.

**MADHARA KWA MAZINGIRA:** ARDENT 50SC ni sumu kwa samaki, viumbe vingine vinavyoitishi kwenye maji na nyuki. Inaweza kudhuru ndege na wanyama.
