Merpan50 WP ni dawa ya kuzuia magonjwa ya kuvu kwenye mimea mabalimbali.

Merpan50 WP inaweza kutumika kwa njia ya kawaida ya kunyunyizia, au kwa matibabu ya mbegu kuzuia magonjwa mengine kama ya mbegu kuoza, magonjwa ya damping-off na baada ya mavuno.

MATUMIZI – KUNYUNYIZIA KWA KUTUMIA BOMBA

Kutayarisha dawa

Changanya kiasi kinachohitajika cha merpan50wp kwa kiasi kidogo cha maji. Ongeza kiasi cha maji kilichosalia na uendelee kutingisa bomba au kukoroga mchanganyiko wa dawa.

Jinsi ya Kutumia

Nyunyizia mimea ya mapambo kwa kutumia kiwango cha chini cha lita 200 za maji kwa hekta. Kwa kiwango cha juu, tumia lita2000 za maji.

Viwango vya kuchanganya dawa zinawezá kuwa tofauti kulingana na magonjwa, laikini kiwango cha 120 GA.I./100 l inaweza kutumika.

Kwa ugonjwa wa “damping off” kwenye maharage, Kabichi n.k., merpan50 WP inapendekezwa kuweka kwenye udongo cm 10 za juu.

Tumbukiza matunda kwa dakika 1-2 kwa 1% mchanganyiko wa merpan kabla ya kuhifadhi matunda.

Matibabu ya mapambo kabla ya kupanda.

Tumbukiza mapambo kwa muda wa dakika 1-2 kwa 1% mchanganyiko wa merpan. MERPAN 50 WP ni dawa inayozuia magonjwa, hivi chanjo la kwanza lazima ifanyike unapohisi ya kwamba magonjwa yataonekana. Marudio lazima yaendeleee unavyoshauriwa.

Mchanganyiko na madawa mengine

Matumizi

Vaa ngao la kujikinga, viatu na vizuizi vya mikono na uso (face shield), unapo tayarisha mchanganyiko wa dawa na maji na unaponyuniza dawa. Jihadhari usipumupi mvuke wa dawa, mchanganyiko wa dawa usiingie kwenye macho au kumwagikia ngozi na nguo ulizovalia. Usinyunyizie dawa hii ukielekea upande upepo unatoka. Usivute sigara na usile wala kunywa wakati unapotumia dawa hii.

Baada ya kazi

Vua nguo za kazi na vizuizi vya kujikinga, osha mikono na uso kwa kutumia sabuni na maji. Safisha bomba la kunyunyizia dawa na mavazi yaliyomwagikiwa na dawa.

Madhara kwa mimea

Haina madhara kwa mimea ikitumika ilivyopendekezwa.

Madhara kwa mazingira

Kuhifadhi

Hifadhi dawa hii katika chombo chake asili ambacho kimefunikwa vizuri na kuwekwa kwenye ghala la madawa lililoidhinishwa. Ni lazima watoto na watu wasio ruhusiwa wakatazwe kuingia kwenye ghala la madawa.



Utupaji

GENERAL INFORMATION

MERPAN 50 WP is an organic protective fungicide of broad-spectrum activity for the control of various fungal diseases on a wide range of crops.

MERPAN 50 WP can be used as a foliar spray, as soil treatment and seed treatment of certain seed rots, damping-off diseases, as post-harvest dip treatment for fruit.

DIRECTIONS FOR USE/FOLIAR APPLICATION

Mixing: Mix the required amount of MERPAN 50 with a little water and then add this mixture to the bulk of required volume of water in the spray tank and agitate thoroughly.

Usage: Apply by means of any suitable high or low volume sprayer as recommended in the table. For low volume applications use at least 200 liters of water per Ha. For high volume application use 2000 liters of water per Ha or spray to run-off. Rates of application vary according to the disease and prevailing conditions, but the figure 120 GAI./100 l water may serve as an indication.

Special users of MERPAN

Pre-planting soil treatment

For control of damping-off and root rots for Beans, Peas, Cabbages etc., apply MERPAN as a broadcast treatment working into top 10cm of soil.

Post-harvest dip treatment for fruits against storage rots

Dip fruits for 1 -2 minutes in 1 % MERPAN suspension before storage.

Dip-treatment for cuttings

Dip cuttings in 1 % MERPAN suspension for 1 -2 minutes. Drain and plant. MERPAN 50 WP is a protective fungicide, so the first application should be made just before the disease is expected to appear, with repeat applications at the recommended intervals for as long as protection is required.



Compatibility

MERPAN 50WP may be combined with most commonly used insecticides, fungicides and adjuvants with the exception of strongly alkaline materials. It should not be used in combination with or closely following oil sprays.

Phytotoxicity

Not phytotoxic to the recommended crops if used according to the label instructions.
