



Who is eligible to enter for Stomping Grounds funding?

To enter, you must be a Canadian citizen and reside in the provinces of Alberta, Saskatchewan, Manitoba, Ontario, British Columbia, Nova Scotia, New Brunswick or Prince Edward Island. Excludes residents of Quebec.

What type of projects are eligible?

Whether it's upgrading your local hockey or curling rink, revitalizing a well-loved baseball diamond, improving community meeting places, supporting agricultural education programs, or strengthening your local food bank, your initiative could make a real difference—and now it has the chance to go even further. We're looking for community-driven projects that bring people together and create lasting impact. If your initiative helps improve shared spaces or supports essential services, it's eligible for this Funding Request. Let's build stronger, more connected communities—one great idea at a time.

What funding is available?

We're proud to be investing a total of \$150,000 into grassroots community initiatives across the country. Each selected project is eligible to receive **up to \$10,000** in funding to help bring the vision to life. Final funding decisions — including which initiatives are selected and the amount awarded—will be made at ADAMA's discretion. Whether big or small, impactful ideas that strengthen communities and bring people together have the chance to receive meaningful support.

How do I enter?

You must submit an official entry form prior to midnight January 31, 2026. Entries will be evaluated and organizations announced for funding by February 13, 2026.

How will the organizations be chosen for funding?

A dedicated panel of ADAMA employees will carefully review every submission to understand the impact, goals, and needs of each initiative. Together, the panel will use a points system to determine which projects ADAMA is able to support this year and how to best allocate the \$150,000 in available funding. Each selected initiative may receive up to \$10,000, with final amounts based on the size, merit, and specific needs of the organization. We know every project represents something meaningful to its community, and while we may not be able to fund them all, we are committed to supporting as many as possible and making a real difference where we can.

Each of the three criteria will be given a rating on each and scores will be determined based on the weight of the category:

- I. Does the proposed project support Community Space Improvement, Agricultural Education or Community Food Bank initiatives started within a year from Funding Request entry? (20%)
- II. Does the entry have a clear plan for effectively utilizing the funding dollars? (40%)
- III. Does the entry clearly depict how the prize money would positively impact the community with the proposed project? (40%)

Judging Scale: 1: Poor. Unacceptable. 2: Weak. Less than Acceptable. 3: Good. Acceptable. 4: Very Good. Above Average. 5: Excellent. Exceptional.

STOMPING GROUNDS FUNDING REQUEST RULES

GOVERNED BY CANADIAN LAW

1. FUNDING REQUEST PERIOD:

This Funding Request starts at 12:00 p.m. CST on October 10, 2025 and closes at 11:59 p.m. CST on January 31, 2026. Decisions on funding will be made by February 13, 2026 and communicated.

2. HOW TO ENTER:

NO PURCHASE NECESSARY. To enter, fully complete the online Official Funding Request Entry Form (the "Entry Form") with all required information, toreceive funding the submission criteria outlined in Section 3 below ("Entry(ies)"). To be eligible to receive funding, your Entry Form must be submitted and received in accordance with these Rules during the Funding Request Period. By entering the Funding Request, you signify that you have read and agree to be legally bound by these Official Rules and Regulations (the "Rules"). All eligible Entries submitted and received in accordance with these Rules during the Funding Request Period will be entered and scored by the panel of judges based on the Funding Request below. Funding Request Entries received by mail will not be accepted.

Projects that are not eligible to receive funding include lobbying, political, religious, or fraternal activities, labor organizations, and as well as any organization that advocates, supports, or participates in activities inconsistent with Sponsor's policies which prohibit discrimination based on protected status including race, colour, religion, gender, gender identity or expression, sexual orientation, national origin, disability, age or status as a protected veteran.

Eligible projects must be initiated within one year of February 13, 2026.

If it is discovered or reasonably suspected by the Sponsor (using any evidence or other information made available to or otherwise discovered by the Sponsor) that any person has attempted to use any means not in keeping with the Sponsor's interpretation of the letter and/or spirit of these Rules to enter or otherwise participate in or to disrupt this Funding Request; then he/she may be disqualified from the Funding Request in the sole and absolute discretion of the Sponsor. Your Entry may be rejected if (in the sole and absolute discretion of the Sponsor) the Entry is not fully completed with all required information and submitted and received in accordance with these Rules during the applicable Funding Request Period. The Funding Request Parties and each of their respective officers, directors, employees, agents, representatives, successors and assigns (collectively, the "Released Parties") are not responsible for (and have no liability in relation to) late, lost, misdirected, delayed, incomplete or incompatible Entries (all of which are void).

3. RECEIVE FUNDING SELECTION PROCESS:

Between February 1 and February 13, 2026, all eligible Entries will be evaluated by qualified judges appointed by the Sponsor. Each Entry will be scored on a scale of 1 to 5 based on the judging criteria outlined below.

Judges will determine the top-scoring Entries as following judging criteria:

- I. Does the proposed project support Community Space Improvement, Agricultural Education or Community Food Bank initiatives started within a year from Funding Request entry? (20%)
- II. Does the entry have a clear plan for effectively utilizing the funding dollars? (40%)
- III. Does the entry clearly depict how the prize money would positively impact the community with the proposed project? (40%)

Judging Scale: 1-5: 1: Poor. Unacceptable. 2: Weak. Less than Acceptable. 3: Good. Acceptable. 4: Very Good. Above Average. 5: Excellent. Exceptional.

The number of chosen organizations will be at the discretion of ADAMA as will the amount of funding given to said organization. By accepting funding, the receive organization: (i) confirms compliance with these Rules; (ii) acknowledges acceptance of the Funding (as awarded); (iii) releases the Released Parties from any and all liability in connection with this Funding Request, his/her participation therein and/or the awarding and use/misuse of the Funds or any portion thereof; and (iv) agrees to the publication, reproduction and/or other use of his/her name, address, voice, statements about the Funding Request and/or photograph or other likeness without further notice or compensation, in any publicity or advertisement carried out by or on behalf of the Sponsor in any manner whatsoever, including print, broadcast or the internet.
