CROP	DISEASE	RATE	CRITICAL COMMENTS
Apples	Black Spot, Glomerella	95 - 125 g/ 100 litres	Apply at 10-14 day intervals, commencing between mid-December and early January.
Bush fruit (Blueberries, Currants, Gooseberries), Brambles (Blackberries, Loganberries, Raspberries, Youngberries)	Botrytis, Leaf Spots		Spray when flowering. Repeat at 7-14 day intervals from flowering until harvest. Use the higher rate when conditions favour infection.
Citrus	Verrucosis, Melanose	156 g / 100 litres	Apply prior to blossoming and repeat when flowering has finished.
Grapes	Anthracnose, Downy Mildew	125 g/ 100 litres	Apply at regular intervals from budburst. Note: Application closer than 3 weeks before harvest may delay fermentation in winemaking.
	Dead Arm		Apply after budburst when shoots are 3 cm long. Note: Application closer than 3 weeks before harvest may delay fermentation in winemaking.
Roses	Black Spot, Powdery Mildew		Apply at regular intervals from budburst.
