#### Section 4. First Aid Measures

Routes of Exposure:

#### Section 6. Accidental Release Measures

#### Environmental precautions

Do not allow into any sewer, on the ground or into any body of water. Prevent product from entering drains. Local authorities should be advised if significant spillages cannot be contained.

#### Methods and material for containment and cleaning up

Contain the spill by damming, recover spilt product by absorbing with sawdust or an inert absorbent material then transfer the recovered spilt material to a properly labelled drum. Deal with all spillages immediately. Dispose of according to Local Regulations.
