Thereafter rinse the empty container three times in succession with one quarter of the container volume fresh water and decant the rinsate into the spray or mixing tank. Puncture the triple rinsed container and dispose of via an approved collector or recycler (www.croplife.co.za).
- Do not bury, burn or donate the container to any other parties that may use it as a container for food or beverages.

FIRST AID

- Do not apply when temperature is very low (0°C) or very high (35°C)

Use 500 ml per 100 L spray mixture or 0.5% solution.

Spoel daarna die leë houer drie keer na mekaar met een kwart van die houervolume vars water en giet die spoelwater in die spuittenk of mengtenk oor Kap gate in die drie keer gespoelde houer waarna dit aan 'n goedgekeurde versamelaar of verwerker oorhandig moet word (www.croplife.co.za).

NOODHULPBEHANDELING

Ingeval van 'n ongeluk of ongesteldheid, verkry onmiddellik mediese advies (wys die etiket waar nodig). Noodhulppersoneel: Let op na eie veiligheid.

Neem die produkhouer of produknaam saam wanneer mediese hulp verlang word.

Oogkontak: Spoel onmiddellik met groot hoeveelhede water. Na oë aanvanklik gespoel is, verwyder enige kontaklense en hou aan met spoel vir ten minste 15 minute. Hou oog wyd oop terwyl gespoel word. As simptome voortduur, skakel 'n geneesheer.

Velkontak: Was onmiddellik af met seep en groot hoeveelhede water terwyl alle besoedelde klere en skoene verwyder word. Raadpleeg 'n geneesheer indien nodig.

Inaseming: Neem na vars lug. As asemhaling onreëlmatig is of stop, dien kunsmatige asemhaling toe. Skakel 'n geneesheer.

Indien ingesluk: Indien by volle bewussyn, spoel mond deeglik met water. Moet NIE braking induseer nie. Moet nooit iets per mond aan 'n bewustelose persoon of 'n persoon met stuiptrekkings gee nie. Indien spontane braking plaasvind, laat die slagoffer vooroor buig met kop na onder om inaseming van braaksel te verhoed. Spoel mond uit en gee nog water. Indien ingesluk, kontak 'n gifstofbeheersentrum of geneesheer onmiddellik.
