Mendoza is a suspension concentrate formulation containing 125 g/L epoxiconazole, a broad spectrum, systemic triazole fungicide for control of *Septoria*, yellow and brown rust, net blotch, *Rhynchosporium*, *Fusarium* and sooty moulds in barley, wheat, triticale, rye and oats and powdery mildew in rye and oats.

Maximum application rate: 1 litre product/ha (125 g/ha epoxiconazole) Maximum total dose: 2 litres product/ha (250 g/ha epoxiconazole)

WILDLIFE	MENDOZA is not classified as 'Harmful to game, wild birds and animals.'
Mammals and Birds	No risk management is necessary to protect wild mammals and birds. MENDOZA is of low toxicity to mammals and low to moderate toxicity to birds. No risk management is necessary to protect wild animals and birds.
BEES	No risk management is necessary. MENDOZA is of low risk to honeybees.
