



# FAQs FOR CAPTAN GOLD® XL

Below you will find frequently asked questions to keep you informed on the latest information regarding application rates, PPE and more for the newest formulation of captan from ADAMA.

## Q. What Personal Protection Equipment (PPE) is required to apply Captan Gold XL?

All mixers, loaders, applicators, and other handlers must wear the following:

- Long-sleeved shirt and long pants
- Shoes plus socks
- Protective eyewear
- Chemical-resistant gloves (see label for details)
- Chemical-resistant apron when participating in dip treatments
- PF10 Respirators or PF50 Respirators (see label for detailed requirements)

## Q. What do I need to know about applying Captan Gold XL and the Endangered Species Act?

When using this product, you must follow the measures contained in the Endangered Species Protection Bulletin for the area in which you are applying the product. You must obtain a Bulletin no earlier than six months before using this product. You must use the Bulletin valid for the month in which you will apply the product.

## Q. What wind speed considerations need to be made for application?

Do not apply when wind speeds exceed 10 mph.

## Q. What rain considerations need to be made for application?

Do not apply this product when soil is saturated. Do not apply when a storm event that is likely to produce runoff from the treated area is forecasted (by NOAA/National Weather Service, or other similar forecasting service) to occur within 48 hours following application.

## Q. Is hand-dipping permitted?

Hand-dipping is prohibited for all crops.

## Q. What are the daily maximum treated area limitations for airblast applicators using an open cab and a PF10 respirator?

- 20 acres/day for almonds
- 30 acres/day for apples, cherries, nectarines, peaches
- 35 acres/day for blueberries
- 40 acres/day for caneberries

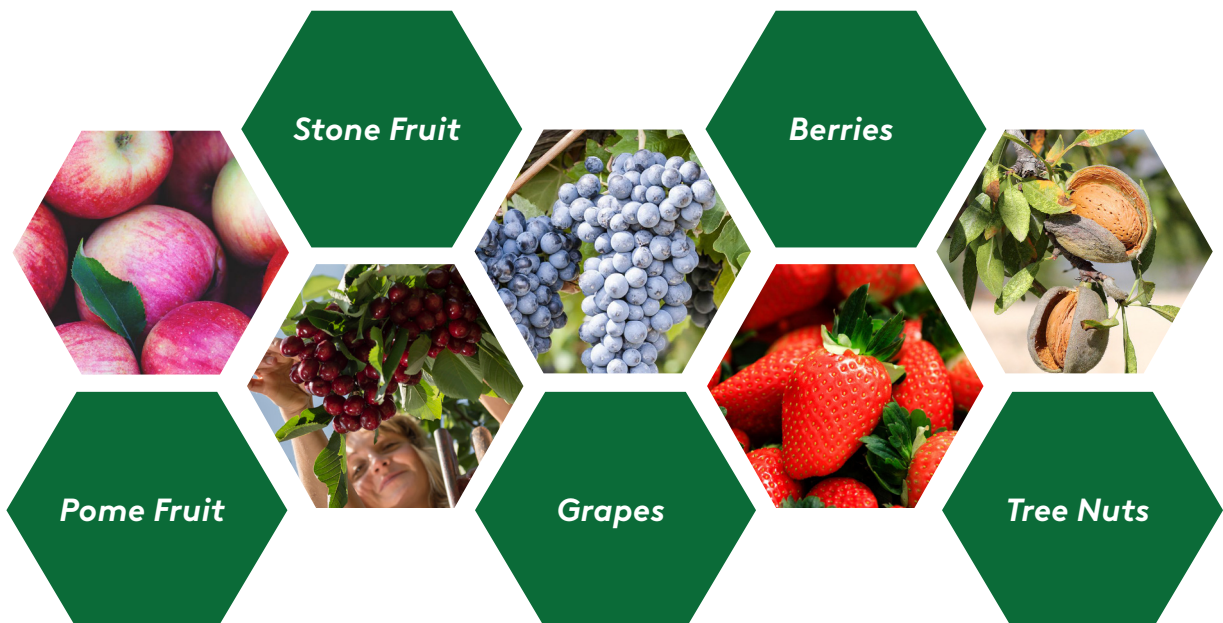
## Q. What are the daily maximum treated area limitations for mechanically pressurized handgun applicators?

- ≤220 gal/day for almonds
- ≤245 gal/day for apples, nectarines, peaches
- ≤325 gal/day for plums, fresh prunes
- ≤490 gal/day for apricots, cherries, grapes
- ≤390 gal/day for blueberries

## Q. Have any of the application rates changed for Captan Gold XL for the labeled crops?

Application rates for Apples, Nectarine and Peaches are reduced based on EPA registration review. Most growers use captan at 2.5lbs to 3lbs AI/A or less. Please refer to label for specific "Directions for Use" applicable to these crops.
