

# Double Team™ FAQ

## How do I become a Double Team Sorghum grower?

The quickest and easiest way to become a Double Team Sorghum grower is to visit the Double Team website: www.DoubleTeamSorghum.com and follow the three-step process that includes signing a Technology Use Agreement and then finding a seed and herbicide dealer near you.

## Can I plant Double Team Sorghum on the same acre in back-to-back seasons?

Do not plant Double Team Sorghum on the same acre in back-to-back seasons.

# What are the double cropping restrictions for Double Team Sorghum?

Double Team Sorghum is very flexible when it comes to double cropping after wheat. If COAXIUM wheat was planted in the field just before Double Team Sorghum, remember: 1) COAXIUM volunteer wheat will not be controlled by FirstAct; 2) Aggressor applications plus FirstAct applications can't exceed 21oz per acre.

#### Are Double Team, igrowth® and Inzen™ technologies the same?

No, they are three different herbicide technologies with different weed control spectrums. FirstAct™, used with Double Team, contains a Group 1 (ACCase inhibitor), while Inzen's Zest™ contains nicosulfuron and igrowth's IMIFLEX™ contains imazamox, a Group 2 (ALS inhibitor).

## Will FirstAct herbicide control volunteer corn?

Yes, unless the volunteer corn is Enlist<sup>™</sup> corn which is also resistant to "FOP" (Group 1) herbicides. This corn type is uncommon.

# Do I have to use Parallel® or Parallel® Plus as my preemergence herbicide?

Parallel and Parallel Plus are the preferred herbicides, but you can use any product that contains metolachlor, dimethenamid-P, or acetochlor and is registered for sorghum.

# Can I tank mix broadleaf herbicide and FirstAct herbicide?

Do not tank mix FirstAct herbicide with other herbicide products. Broadleaf products are recommended for application at least seven days before FirstAct applications.

#### When can I make first application of FirstAct herbicide?

Plant size (height or leaf number) is used to determine spray timing. The plant needs to be at least 11 inches tall, or at the 8-leaf stage.

#### How many times per season can I spray FirstAct herbicide?

Two applications are allowed with a maximum of 21oz of FirstAct per acre.



# How late can I spray FirstAct herbicide?

FirstAct applications can be made up until the sorghum plant reaches the boot stage. FirstAct has a 45-day pre-harvest Interval (PHI).

# Are adjuvants required with FirstAct herbicide applications?

Yes, crop oil concentrate (COC) is recommended at 1% v/v.

# What carrier spray volume is needed for FirstAct applications?

Ground applications are labeled at a minimum of 10 gallons per acre but for better coverage, 15 gallons per acre is highly recommended, especially under drought stress.

# Are Double Team hybrids Sugarcane Aphid (SCA)-tolerant?

There are now Double Team Sorghum hybrids with moderate and high resistance to SCA. Check with your Double Team seed supplier for more information.

### Can glyphosate herbicides be sprayed over the top of Double Team sorghum?

No, glyphosate and products like Select (or any DIM chemistry) will kill Double Team sorghum. Glyphosate and other registered products can be used in burndown prior to planting.

## Is there a yield drag with this trait?

No, yields have been equal to or higher than similar maturity hybrids.
