### DESCRIPTION:

Agil 100 EC is a selective, systemic post-emergence herbicide formulated to control grass weeds in a wide range of broad-leafed crops.

### DIRECTIONS FOR USE

**General agricultural use:** Apply Agil 100 EC at 0.75-1.0 L in 200 L of water per hectare OR 60-100 ml per 15 L of water (knapsack sprayer).

**Mixing:** Fill the spray tank with half the required amount of water. Add the recommended amount of Agil 100 EC and mix thoroughly. Top up the spray tank with water to the required level and agitate well to ensure thorough mixture.

**Usage:** Start application only when weeds emerge; often 6 weeks after transplanting or planting, OR when weeds are at 5-8 leaf stage.
